

# Digital consent, Privacy Policy and User Data agreement (e-Consent)

This is applicable to all Digital Communication channels: WhatsApp, Website, E-mail and Social Medias.

# A. Digital Consent

**Introduction.** Island Finance Curacao and its subsidiaries and affiliated companies (hereinafter, jointly the "Companies", "we", "us"), we may request information about your credit history as well as send you, by digital means such as email or social networks, with your express consent provided here, the information about your application or loan request or the information indicated in the Privacy Policies, required by electronic means (the "Required Information"), and we may use electronic records for your transactions with us. Therefore, please review the terms of this Consent Agreement before giving your approval and retain a copy of this Consent Agreement on file.

If you do not wish to receive the Information required by digital means for your transactions with us, or do not wish us to request information about your credit history, you must not agree to the terms of this Agreement. If you do not consent to receive the requested Information digitally, or do not agree to the use of digital means for your transactions with us, or do not authorize us to request information about your credit history, we will not be able to proceed with the acceptance and processing of your transaction, and you must visit Island Finance to request a loan.

If you wish to proceed with your loan application through any Digital Communication Channel, you must give your consent so that we can process your loan application and send the required information by digital means.

Your consent will apply to all your transactions with us and to any required Information that we provide or make available to you. Your consent also permits the general use of digital records in connection with all your transactions with us.

- I. Consent **Required Information:** You hereby give your express consent to receive, by digital means, the required Information, such as communications or notifications from the Companies regarding information related to your application or loan request; confirmations of transactions carried out with us, offers of products and services offered by the Companies. You also consent to the Companies using digital electronic records in connection with your transaction(s) instead of paper documents and handwritten signatures, and to receive digital communications.
- II. Consent **Printed Copy.** Printed copy of the required Information available to you upon request Free of charge. If you consent to receive the Requested Information digitally, you may also request a paper copy of the Requested Information by calling any Island Finance branch. We will not charge you anything to provide you with a paper copy of the Requested Information. Your consent does not mean that the Companies must provide the Requested Information digitally, but rather that they may do so. The Companies may, if they so choose, provide the required Information in printed form. The Companies may also require that certain communications from you be sent to the Companies in hard copy at a specified address.
- III. Withdrawal of your consent Required information. You may withdraw your consent to receive the required information, or notifications in connection with any future transaction with us, at any time. We will not charge you anything for withdrawing your consent. If you decide that you do not wish to receive the requested Information by digital means, in connection with future transactions with us, you may withdraw your consent by calling us at your preferred branch.

# IV. Consent: Processing (Personal) Data

Island Finance Curacao, hereinafter referred to as 'Island Finance', will process the personal data of the debtor and the representatives of the debtor as well as the data related to the loan agreement in accordance with applicable legislation. Island Finance is permitted to share and exchange such (personal) data within the group to which Island Finance belongs and with any successor and any service provider of Island Finance or its successors in connection with (i) the proper execution of the loan agreement or (ii) a



contract takeover of the loan agreement by any successor of Island Finance, as well as the transfer by Island Finance of existing or future claims on the debtor to any successor of Island Finance. (Personal) data can also be shared with third parties that Island Finance or its successors use in their operations or services.

- **IV. Updating your contact information.** If you consent to receive the required Information digitally, we will contact you at the cell phone number provided through any **Digital Communication channel**. If you change your cell phone number, you can give us your new contact details by phone, message, or the contact us form included on the website
- V. Computer system requirements to access the required Information. To access the

Required information that is provided to you by digital means, you must have the following:

- A personal computer with Internet access and one of the following combinations of operating system and web browser installed on it:
  - Internet Explorer ver. 8.0 or more updated ones.
  - Mozilla Firefox ver. 3.6 or more updated ones.
  - Chrome ver. 38 or other more updated ones.
  - Safari view. 5.1 or more updated ones.
  - Opera see. 25 or other more updated ones.
- A cell phone with Android or iOS operating system with internet access and download of the social network WhatsApp.
- VI. **Electronic Communications:** We may contact you via WhatsApp, mail, telephone, text or electronic messages/SMS, or emails to process your request, to provide service to your account or in connection with collections, to inform you about financial products and services and for other commercial purposes. BY PROVIDING YOUR CONTACT INFORMATION, YOU EXPLICITLY ACKNOWLEDGE AND AGREE THAT THE COMPANIES MAY CONTACT YOU AT ANY OF THE TELEPHONES, WHATSAPP SOCIAL NETWORK OR EMAILS PROVIDED, REGARDING ANY MATTER RELATED TO YOUR ACCOUNT AND IN ADDITION TO RECEIVE PROMOTIONS, OFFERS AND/OR MARKETING PARTS OF OUR PRODUCTS. IT WILL BE YOUR RESPONSIBILITY TO UPDATE THE CONTACT INFORMATION PROVIDED, SO YOU RELEASE THE COMPANIES FROM RESPONSIBILITY FOR INFORMATION SENT TO THIRD PARTIES THROUGH ANY OF THE CONTACT INFORMATION PROVIDED. IN ADDITION, COMPANIES MAY PROVIDE CONTACT INFORMATION FOR COLLECTION PURPOSES.
- VII. **Applicable law and jurisdiction:** This Agreement will be governed and interpreted in accordance with the laws in force in **Curacao** Courts and will be competent to hear any claim or controversy related to this Agreement.
- VII. Acceptance of Agreement / Accuracy of Information: You agree to be bound by the terms of this Agreement and confirm that the cellular or computer equipment and software you are using meets the requirements indicated above. You hereby further confirm that you are the person you claim to be in the application, and you acknowledge that any false representation or declaration regarding the identity provided here will be sanctioned in accordance with the criminal laws of Curacao and constitutes an act fraudulent to the detriment of the Companies. By checking the acceptance box, you affirm that you are aware of everything stated herein and you freely and voluntarily accept and consent to this agreement.



# **B.** Privacy Policy

#### Introduction

This policy discloses what information we collect and how we use it, as well as the choices you have about the way your information is collected and used. We also explain how personal and/or personally identifiable information we may request will be used; These explanations can generally be found on the same pages where the information is requested. We also detail below our security policy that describes how your personal information is protected both electronically and physically.

In general, and as described in detail below, we collect several types of information from you:

- Personal information necessary to verify your identity
- Personal and financial information necessary to evaluate your eligibility to borrow money
- Optional personal information that you authorize to be shared in the use of our website.
- Information about your visits to and use of this website or third-party service websites to help us maintain appropriate features, functionality, and user experience.

# The information we collect from and about you

We collect personal and financial information from you while you are active in our conversations on any **Digital Communication channel**, and most of this collection occurs during the conversation. Certain information is required and some other is optional, some will be shown to Island Finance Curacao employees who work with said information and/or third parties in the performance of services. We'll always let you know which is which. You may obtain additional information during your further use of any **Digital Communication channel**, whenever you choose to provide it.

Certain personal information must be provided during the conversation through any **Digital Communication channel**, as indicated below, in order to (a) allow users to initiate a digital conversation, (b) determine the eligibility of users for a loan through our proprietary credit evaluation process, (c) verify identities, (d) establish the ability of users to apply for a loan by verifying that they are at least 18 years of age, and (e) provide protection against potential fraud. This basic personal information includes:

- Name
- Email
- Date of birth
- Residential address and telephone
- Cell phone
- ID number

By starting the digital conversation and actively being a user of Island Finance Curacao, we will also use your required and optional information to facilitate activities and transactions that must occur during the loan process, such as:

- Assigning a credit score to users based on their financial circumstances
- Enabling our financial services partners to implement automatic payments and fund transfers
- Contact you if there is a problem completing a transaction you have requested or to discuss a problem with your account
- Implementation of collection activities, as necessary
- Maintain regular communications with you about your transactions, such as: requesting information or assistance, filing a loan application.

In addition, we collect the names, email addresses and cell phone numbers of people who contact us through our digital customer service channel with questions about our company or loan/credit operations. We collect this information for the sole purpose of answering those questions and do not store contact information unless approved by individuals, such as for job applicants submitting resumes, credit references, etc.



Finally, we collect information about your cell phone number, first name, last name and email address during your conversation with us through any **Digital Communication channels**. We use this information obtained through any digital communication channel to activate marketing and advertising campaigns and activities.

Island Finance Curacao, a company organized according to the laws of Curacao with legal domicile at Kaya Shon Toni Prince No. 24, hereinafter referred to as "Island Finance", responsible for the processing of the personal data of the debtor and the representatives of the debtor, as well as data related to the Loan Contract in accordance with applicable laws. Island Finance Curacao may exchange personal data within the group to which Island Finance Curacao belongs or with any successor in title and any service provider of Island Finance Curacao or its successors in connection with (i) fulfillment of the Loan Agreement or (ii) the transfer of title of Island Finance Curacao on the Loan Agreement and/or any existing or future receivables against the debtor to any of Island Finance Curacao's successors in title. Personal data may also be exchanged with third parties that Island Finance Curacao or its successors in title use in their commercial operations or in the provision of their services. Personal data will be retained in secure databases for a period of up to 12 years from the date of your loan application regardless of the outcome of your application or the date of the contract.

You as a natural person and owner of personal data and in compliance with the Personal Data Protection Ordinance, have the right to access, rectify, cancel and carry your personal data stored in Island Finance Curacao, in addition to opposing its processing.

# Communications from our service channel through the Digital Communication channels

When you initiate a conversation through our **Digital Communication channels**, you will receive messages via chat that confirm specific actions required. You will receive a message that confirms your activation as a user of the Island Finance Curacao **Digital Communication channels** platforms, the successful verification of email addresses, cell phone numbers, accounts, and confirmation of successful filing of loan applications. We may also send responses to emails you send to us, if applicable. From time to time, we may also send user surveys, requests for feedback regarding user experience, our marketing, commercial communications or offerings of products and services. Completing these surveys or requests for information or accepting any offer is strictly voluntary. If you do not wish to receive these offers, surveys or emails, please use option 6 of our WhatsApp menu or fill out the Contact Us form and put your instructions in writing, along with your full name, ID number or personal identification number and cell phone number.

# **Privacy Policy**

These reviews may be conducted by our internal staff, external accounting and auditing firms, and government regulators. Included in these self-assessments and reviews are opinions of controls and measures related to consumer privacy.

# **Links to Third Party Websites**

Island Finance Curacao is not responsible for the information practices used by links linked to or from any **Digital Communication channel**. Third party links may have different privacy policies and/or security standards. How and when your information is shared with third parties Information is shared with third parties in the following ways:

- Necessary information and optional information about users displayed in user profiles may be shared for marketing purposes, surveys and/or in the performance of the services; Certain information is optional, and you can choose not to provide and/or remove this optional information at any time. Island Finance Curacao may, but is not obligated to, monitor any optional information you have provided to assist in protecting your identity.
- Island Finance Curacao may, with your consent, share required or optional information about you.
- We may share your information with appropriate authorities as required by law or for fraud
  mitigation purposes. We reserve the right to disclose your personal information when we believe

#### **Social Media Widgets**

Our website includes social media features such as the Facebook logo. These features may collect your IP address, the page you are visiting on our site, and may set a "cookie" to enable the feature to function properly. Social media features are located with a third party or hosted directly on our site. Your interactions with these features are governed by the privacy policy of the company in charge of it. Temporary Files "Cookies"

We use cookies to remember user settings. Users can control the use of cookies at the individual browser level. If you reject cookies, you may continue to use our site, but your ability to use some features or areas of our site may be limited.

# How your loan information is shared with Island Finance

When you apply for a loan or submit personal information through any **Digital Communication channel**, that will be visible to certain Island Finance Curacao employees. This information includes details about your loan application, as well as your geographic location, Island Finance Curacao loan history information and the purpose for which the loan will be used.



Qualified employees of Island Finance Curacao will also see certain credit data collected or calculated based on their central risk file. The credit profile section includes your:

- Loan History
- Debt-to-income ratio (DTI)
- Gross income
- Ownership Status
- Current employer and time in position
- Existing debt payments (monthly snapshot of your current outstanding debt)
- Monthly payment amount for the loan being requested

#### **Notifications**

Island Finance Curacao will send you email notifications from time to time, and these are necessary elements of your transactions on our website, such as confirmations of specific actions you have taken. These required notices are typically sent to let you know about a change, such as when you are confirmed as a borrower, or for legal or security purposes. For example, some notifications are sent for your own protection to ensure that no one can make a change to your account without your knowledge, such as: confirmation that you have added a new email address. These notifications are sent so that you can be sure that no one is making changes to your account without your knowledge. In other cases, these notices involve changes to various legal agreements or site policies. In general, you cannot initially opt out of receiving these service-related emails, however, you may withdraw your consent to receive such messages by following the form and processes set forth in our electronic messages and/or or in the electronic consent agreement (E-Consent).

#### Your information

You may receive notification of your personal information collected online in our registration section. This section of the site is password protected to better protect your information.
